

Freedom Celebration 2010

Dear Food Vender,

As the Champaign County Freedom Celebration draws near, we would like to take this opportunity to invite you to participate in the event. We are seeking food vendors to operate along the parade route and during the evening fireworks celebration. In past years, concessionaires have experienced strong profits from a relaxed, happy, and hungry crowd. Just think how much your business could benefit by participating in this year's Champaign County Freedom Celebration! Please see below for important information:

Dates and Times

This year's Freedom Celebration will be held on Sunday, July 4th. *In the case of inclement weather, the parade and the evening celebration will be canceled.* The parade will begin at 1:05pm and will end at approximately 3:30pm. All food vendors must have their units in place along the parade route by 9:30am. Following the completion of the parade, food vendors must move to their assigned locations for the evening program. The evening program begins at 7:00pm and will continue until approximately 10:00pm. All vendor location will be determined by the Champaign County Freedom Celebration committee, and will be assigned by June 28, 2010.

Fees

Single Unit, Fixed location (parade and fireworks) - \$150.00

Single Unit, Fixed location (parade only) - \$100.00

Single Unit, Fixed location (fireworks only) - \$100.00

Two Units, Fixed location - \$250.00

Walk Unit Affiliate with Paid Fixed Unit - \$50.00 (in addition to fee for fixed unit)

Walk Unit, Independent - \$125.00

A \$50.00 non-refundable deposit is required at the time of application. Please note that spaces are limited, so please register early. If there is not a spot available at the time of application, you will be issued a full refund. **The remaining balance must be paid in full by June 28, 2010. Failure to comply could prohibit the food vender from participating in the event.**

Electricity

The Champaign County Freedom Celebration is unable to provide food vendors with power, water, supplies, and/or any other support material. Food vendors are required to supply all necessary power and equipment.

Permits

All food vendors are required to obtain/show proof of the appropriate health and vending permits necessary to operate at the Freedom Celebration. **A copy of this permit must be provided to the Champaign County Freedom Celebration Committee by June 28, 2010. Failure to comply could prohibit food vendors from participating in the event.** These permits must be appropriately displayed for the duration of the event.

Insurance

All food vendors are required to obtain liability insurance that names "Champaign County Freedom Celebration Committee, Inc.". "The City of Champaign", "The University of Illinois", "Parkland College" and "Champaign Park District" as additional insured. The dates of coverage should be Sunday, July 4th. **A copy of this insurance coverage must be provided to the Champaign County Freedom Celebration committee by June 28, 2010. Failure to comply could prohibit food vendors from participating in the event.**

Beverages

The University of Illinois is not receiving any profits for goods sold at the parade and will permit sales of either Coke or Pepsi products.

The evening show is at Dodd's Park which is located just east of Parkland College in Champaign. The park itself is Champaign Park District territory which has Pepsi as their exclusive beverage vendor. Parkland College does not have a contract with either company.

Pizza

Papa John's Pizza is a sponsor of this event, and will be selling pizza at this event.

I hope you will consider participating in the Champaign County Freedom Celebration. For your convenience, I have enclosed a vender application with this letter.
